Introduction and Summary:

Sealed Air offers a range of freight options for valued customers. This document provides a comprehensive summary of the Standard Freight Policy for North America (including the U.S. and Canada).

For many of Sealed Air's products, Prepaid Freight is offered if certain requirements are met including (1) ordering a full truckload of product which fills a truck by volume or (2) ordering a minimum dollar amount of product at any one time. To help achieve dollar minimums to qualify for Prepaid Freight, Sealed Air allows certain options to combine products on a truck. Other services provided include pool trucks, drop shipments, customer pickups and expedited shipments, which provide our customers with a range of transportation options to suit individual needs.

Expedited Orders

Customer requests to expedite an order of material (defined as an order for shipment inside lead time) are subject to a \$500 expedite fee for all products. Sealed Air encourages customers to order for delivery at standard lead times to avoid this fee. Any waivers to this fee will be handled by exception only and require SEE Sales VP Approval.

Drop-Ship Service

Sealed Air offers a drop-ship service that will deliver products directly to end users on behalf of channel partners. These orders will be shipped according to the General Freight Terms for All Products (pages 3 – 6). Channel partners interested in this option should contact a Sealed Air sales representative.
